#### SECTION 4: First aid measures

##### 4.1. Description of first aid measures

<b>General information</b>	If in doubt, get medical attention promptly.
<b>Inhalation</b>	Move affected person to fresh air at once. If breathing stops, provide artificial respiration.
<b>Ingestion</b>	Get medical attention immediately. Keep affected person warm and at rest. Do not induce vomiting.
<b>Skin contact</b>	Remove contaminated clothing immediately and wash skin with soap and water. Do not use organic solvents.
<b>Eye contact</b>	Wash with plenty of water.

**Protection of first aiders** First aid personnel should wear appropriate protective equipment during any rescue. ### 4.2. Most important symptoms and effects, both acute and delayed

**Inhalation** Vapour from this product may be hazardous by inhalation. May cause respiratory irritation. Prolonged or repeated exposure may cause the following adverse effects: Coughing. Vapours may cause drowsiness and dizziness.

**Ingestion** Pneumonia may be the result if vomited material containing solvents reaches the lungs. May be fatal if swallowed and enters airways.

**Skin contact** Prolonged contact may cause redness, irritation and dry skin.

**Eye contact** Causes serious eye irritation. Prolonged or repeated exposure may cause the following adverse effects: Profuse watering of the eyes. Redness.

### 4.3. Indication of any immediate medical attention and special treatment needed

## SECTION 5: Firefighting measures

### 5.1. Extinguishing media

**Suitable extinguishing media** Extinguish with alcohol-resistant foam, carbon dioxide, dry powder or water fog.

**Unsuitable extinguishing media** Do not use water jet as an extinguisher, as this will spread the fire.

### 5.2. Special hazards arising from the substance or mixture

**Specific hazards** The product is flammable. Fire-water run-off in sewers may create fire or explosion hazard. Harmful to aquatic life with long lasting effects. Control run-off water by containing and keeping it out of sewers and watercourses.

Inhalation of dust during cutting, grinding or sanding operations involving this product may cause irritation of the respiratory tract.

### Appropriate engineering controls

As this product contains ingredients with exposure limits, process enclosures, local exhaust ventilation or other engineering controls should be used to keep worker exposure below any statutory or recommended limits, if use generates dust, fumes, gas, vapour or mist. ### Eye/face protection
